Where loss or damage to the Property, the Inventory, or equipment exceeds the amount of the security deposit, the Rental Company or the Owner will bill the Guest for the shortfall, and the Guest agrees to pay. In the event that the Guest fails to pay any such shortfall, the Rental Company or the owner reserves the right to exercise any legal remedies to pursue the amount owed from the Guest.
